ITEM ND. 1: CALL TO ORDER	Chairman Mincer called the meeting to order at 7:30 pm opening with the Pledge of Allegiance.
ITEM NO. 2: APPROVAL OF MINUTES	MOTION was made by Ed Nikles, seconded by Dennis Brink, and unanimously carried to approve the April 6, 2021 Minutes as presented.
ITEM ND. 3: COVID-19 RELATED	Governor Wolf has announced that all mitigation measures will be lifted on May 31 2021 except for the Mask Order, which will remain in effect until Pennsylvania has attained a 70% vaccination rate.
ITEM ND. 4: OLD BUSINESS A) Sunrise Lake Section 9	The Board was in receipt of an email from Jim Ott that the alarm and auto dialer will be installed today. The tanker pad was previously installed.
ITEM ND. 4(B): Garage Project Change Order #1	The Board was in receipt of an email from Mar-Paul informing that the increase for going from 12' to 14' wide garage doors is \$2,043.16. However, it is unclear if that is the total cost for the four doors, or each.
